

Write & Illustrate Competition 2018
(in conjunction with ACE2018)
Terms and Conditions

Eligibility and Registration

1. The Competition is open to all students in schools or institutions of higher learning in Malaysia.

Specific Eligibility Rules

2. All participants must be full-time students in a primary school, secondary school or an institute of higher education registered with the Ministry of Education Malaysia.

Changes or Extension

MINDS reserve the right at any time without any reason or prior notice to change the notification and submission dates, to extend or shorten the competition.

Disqualification

3. Any of the following shall disqualify the participant from participating in the competition and from the award of any prizes:
 - (a) Late registration in the competition, or late submission of the entry (story plus illustration);
 - (b) Ideas for all stories/illustrations which do not originate from the respective participants;
 - (c) Stories/illustrations which infringe upon the intellectual property rights of third parties;
 - (d) Submission of any computer-assisted or digitally-modified illustrations;
 - (e) Failure to submit original stories/illustrations within the required time period, upon request;
 - (f) Participants who cease to be students at any point of time during the competition period;
 - (g) Failure to comply with or breach of any Rule or Terms herein;
 - (h) Participants who provide false registration details, or indulge in any dishonest or fraudulent activity, cheating, abuse or misuse of the competition, or in any other misconduct.

General

4. MINDS reserve the right to change or delete any of the Rules or Terms, or to introduce new Rules or Terms, at any time without prior notice.
5. Upon participation in the competition, all participants agree and consent that the competition winners may also be required (as notified by MINDS) to attend events relating to the competition, including any prize presentation ceremony. Expenses and/or costs incurred for such attendance will be borne entirely by the competition winners and not by MINDS.
6. The competition including the Rules and Regulations, and Terms and Conditions, are governed by the laws of Malaysia.

Exclusion of Liability

7. MINDS shall not be liable for any injury, death, illness or medical condition, distress, costs, expenses, loss or damage, arising out of or in connection with participation in this competition and subsequent exhibition.

Indemnity

Each participant agrees and undertakes to indemnify MINDS against any claims, legal proceedings or liability, made or brought by any person(s) against or incurred by MINDS in respect of, arising from or consequential to any act, omission, negligence or breach of or non-compliance with the Rules or Terms by the participant.

Intellectual Property Rights

9. The participants agree that upon the submission of the stories/illustrations for the competition, the participants will transfer, assign and confer all title, interest, ownership of or related to the intellectual property rights, including the copyright of the stories/illustrations, to MINDS.

Prize Terms

10. Prizes are subject to change and will be awarded at the sole and absolute discretion of MINDS.
11. All notifications to winners shall be based on the contact and mailing details as provided in the registration form, and MINDS is shall not be liable for any delay or non-delivery/non-receipt of notification.
12. No subsequent claims on the prizes or related correspondence will be entertained.
